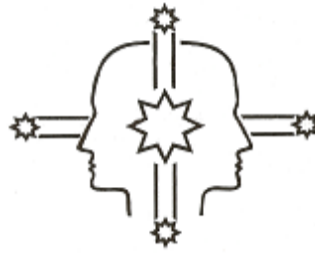

Australia First Party elects a Councillor in Penrith City -

Maurice Giroto Makes History As Tide Turns For Australian Nationalism

THE victory of Maurice Giroto in taking a seat on Penrith Council on September 8, has sent a strong electric jolt into Australian nationalist and other patriotic people.

Mr. Giroto took a seat for East Ward, winning just under 10% of the poll which was about 3000 votes.

This win was the first by any candidate of a generally patriotic type for several years. The general dry up of voting support for the One Nation party saw it lose its last Senator in 2007 and the last of its parliamentarians (who by then sat as 'independents'), not long after. Other than some strong Council results by Australia First after 2008, votes for all 'patriotic' parties in Federal elections was generally in the fringe-party range.

Australia First Party operated tickets in a number of Greater Sydney cities and shires and the Blue Mountains for the September elections. The party won some 5% in Hawkesbury and over 7% in Wollondilly. In that area of far-western Greater Sydney, there reasonably exists a base of consistent support, not simply electoral support, but support at the base level. Indeed, it was noted by Australia First polling workers in Hawkesbury and Penrith, that the obvious voters for the party were younger people, young workers and family people. This was observed as

the most positive aspect of the campaign. The younger clientele means that it may be more consistently developed into an activist movement.

The issues

The party opted *not* to campaign as the 'electoralist' parties do. Electoralists (like the former One Nation) usually try to cobble together a 'clever' programme that supposedly articulates what passive voters might really want, then campaign in a way with 'safe' press releases and a gentle 'image'. Usually, the voters reject them.

Australia First decided to campaign for real change in the community instead and to fire those issues with an over-riding message *that the heritage and identity of the target areas was under attack via the populationist policies of the major parties*. Whole zones, from Wollondilly in the south to the Hawkesbury in the north, were slated for an immigration-driven explosion of numbers, housing, pollution and the destruction of farms and industries.

In Hawkesbury and Penrith, Australia First stood up for the homeless and developed a policy for a housing cooperative which will be rolled out in greater detail in coming months, to serve the homeless and the under-housed. Party members also joined groups that were working with the homeless to provide a meal

and other necessities. Party advertisements denounced the Liberal Party for its policy against the construction of new public housing and for not acting decisively to assist the homeless.

The election of Maurice Giroto is the signal that the forces of Australianism are reorganizing.

In the campaign, aside from Aussie youth, the party made voters of truckies, farmers and pensioners, small-owners and shooters, all constituent elements in the Real Australia fight-back against the economics and politics of globalism.

The party showed itself professional in its operations. It leafleted areas, canvassed votes, purchased radio time and newspaper space and conducted public efforts and meetings. The party owes much to its members who had saved money especially to donate it to this cause and who took the time to perform whatever function the party asked. Their dedication was rewarded.

The party has received enquiries from many ordinary people and will maintain proper branches in several areas. The achievements of the party generally and the election of Maurice Giroto inspires action!

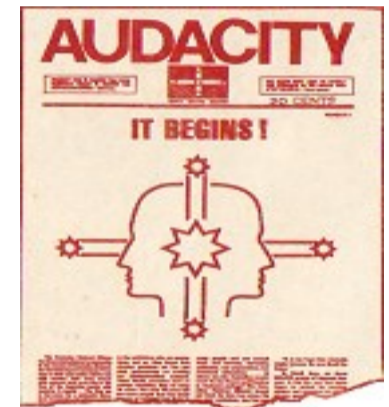

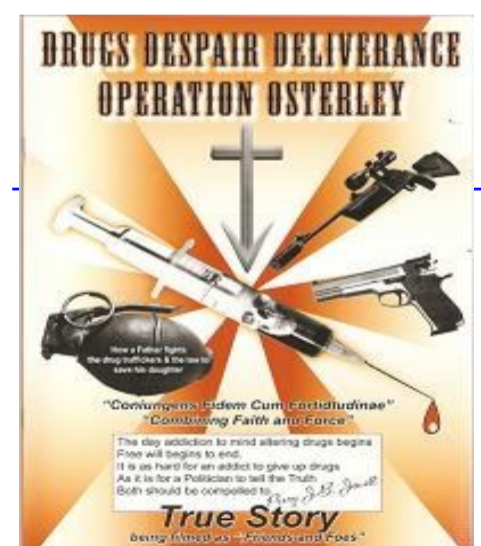

The Falsification Of Australian Pre-History

As a historical researcher for some years now I have been appalled at the gradual erosion of our history by liberal and Marxist-inspired academics intent upon pushing a left-wing version; namely that our forefathers 'invaded' this continent and 'stole' it from its owners the Aborigines, who are supposed to be the 'traditional owners' being the 'First Australians'.

Aided by the globalist university element, and the Marxist teachers in our schools pushing White self-hatred propaganda laced with multi-cultural rubbish on our young people, some Aboriginal community leaders are lately talking of making Australia a sovereign Aboriginal nation, seeking United Nations stand-over help in achieving their goals. This anti-white push now extends to Australian prehistory research.

For some years now there has been an attempt by stealth to falsify all evidence of Aboriginal occupation of this Continent to make it appear that there were no other Stone-Age races here before them. The Aboriginal lobby has come to obtain such power from our sell-out political leaders that in the 1980s they were successful under the Hawke Government in having all Aboriginal skeletal remains in government museums and universities returned to them for 'reburial' or else those remains allowed to stay in universities must remain under lock and key and scientists must ask permission of Elders to open locked drawers even in their own departments and that an Elder must be present to advise them on what they may pick up and look at, photograph or study.

This nonsense extends to actual field archaeology, which is now virtually non-existent. Certain books and papers on Aboriginal archaeology, their ceremonial life etc. are now likewise banned from viewing. Anthropological displays in government museums are likewise being dismantled and replaced with exhibitions of what the activists choose to allow the public to know.

For example the former "Tracks through Time" exhibition in the Australian Museum in Sydney no longer exists, the entire human evolution display has been replaced with wall-size photos of Aboriginal demonstrators and a few stone tools and photos of traditional Aboriginal life with displays on the 'Stolen Generation' propaganda and the "We wuz robbed" of our 'Sacred Land' lie!

The Marxist-inspired Aboriginal flag must now be flown alongside the Australian flag on all government buildings, City Council buildings, schools etc. We are now a divided nation whose political leaders seem helpless to prevent the burning of our flag by Aboriginal demonstrators or the desecration of historic monuments by these people who see them as symbols of British colonialism and domination. They choose to forget all the benefits they enjoy because of our culture.

One night in recent times activists torched the historic Marked-Tree outside Katoomba, once initialled by Blaxland, Wentworth, and Law-

son during their epic May 1813 crossing of the Blue Mountains.

In 1966 my late parents and I began plans for the construction of a monument at the top of historic Cox's Road, at Mt York, near Mt Victoria to commemorate the arrival there on May 28th 1813 of Blaxland, Wentworth and Lawson during their crossing of the Blue Mountains. An Austrian sculptor made the heads of the explorers to be placed on the top. It stood near my former Mt York Natural History Museum. The monument was officially opened in September 1969, but the heads were smashed one night a few years ago by Aboriginal activists!

Now the push is on to make it law within our constitution that the Aborigines are the 'First Australians'. That means I will one day be breaking the law presenting talks with fossil evidence proving they are not the so-called 'First Australians'!

This madness must be opposed along with the attack on Free Speech in this country just as we must reverse the racial suicide threatening our entire European way of life.

Back in the 1980s when the then Prime Minister Bob Hawke gave the Aborigines the right to seize fossil Australoid remains for reburial, Professor J.B. Mulvaney, Professor of Anthropology at Sydney University begged Hawke not to permit this action, warning him that, quote: "If you allow this to happen Australia will become the laughing stock of the scientific world. We will become known as the only nation on earth reburying it's past"- and that is exactly what has happened. Now that archaeological fieldwork is virtually non-existent, having been forbidden by standover Aboriginal radicals, scientists and students alike have been prevented from examining fossil remains. Anthropological research has virtually ceased and classes on this subject closed for lack of students.

What follows is 'forbidden' fossil evidence that, if it were allowed nationwide attention would utterly smash Aboriginal Land Rights and the entire 'First Australians' nonsense.

Aborigines by their own admission and the findings of previous scientific studies, date Aboriginal arrival back at least 50,000 years...

If this is so, then what primitive hominid left mineralised feet impressions in a volcanic ash deposit, laid down at a Kanangra Boyd National Park site in Pliocene times some 4 million years ago!

In June 2005 beneath ancient ash deposits at a 60 metre tall volcanic plug site near Bega, on the NSW far south coast I unearthed an endocast of a primitive hominid-like skull near the base of the formation.

Then in March 2006 on another search here I unearthed two more. With their long, narrow ie doliocephalic] skulls these creatures were obviously a very primitive form of human ancestor.

I soon learnt that Australian National University vulcanologists had already dated this and several other

volcanic plugs and their ash deposits in the Bega district to around 7 million years BP [Before Present].

When I announced finding of my 7-million year old skulls in the Bega Newspaper there was a wave of academic hostility followed by the suppression of my discovery in the media.

Meanwhile in January 2005 I uncovered a primitive ironstone mineralised hominid skull from a deposit dating between the end of the Pliocene and beginning of the Pleistocene period near Katoomba. This suggested the skull was at least 2 million years old.

Like the Bega fossils, the Katoomba skull possessed a long, narrow braincase [ie doliocephalic] with the remains of a pointed sagittal crest, with thick brow ridges housing large eye sockets bulging outwards from the skull and a forward projecting face. There was no lower jaw and the skull had suffered distortion in the early stages of fossilisation.

However, what was most startling about this skull was that it possessed features identical with robust Australopithecines seen here that inhabited Africa 2 to 4 million years ago. Since this find I have added several other Australopithecine-type skulls to my collection from other areas of western New South Wales and the Northern Territory. The evidence suggests that bands of Australopithecines wandered out of Africa at a remote period to reach Asia and eventually cross over a former land shelf that linked mainland Asia with Australia in Pliocene times.

The Bega fossils are, I now believe, an earlier form of bipedal herbivorous primate ancestral to the Australian Australopithecines. I now call them *proto-Australopithecines*, I have also named the Katoomba skull *Australopithecus australis Gilroy*.

The presence of Australopithecines in Australia alone makes the date of Aboriginal arrival in Australia pale into insignificance by comparison!

There was more than one species of Australopithecine in Africa and the same picture is forming in Australia. Basically there were two forms, herbivorous and omnivorous. Argument continues as to whether there were tool-making Australopithecines. sharp-edged stones called 'eoliths' have been found with some African

Australopithecine remains, suggesting the beginnings of stone tool manufacture, going back over 2 million years.

At a Bathurst district creek site in July 2007 I unearthed another *robust Australopithecine* mineralised skull.

The skull came from 'dawn' Pleistocene deposits dating back around 2 million years BP [Before Present].

By around 1.8 million years ago *Homo erectus* had evolved from a form of Australopithecine in Africa and gradually spread out across the Euro-Asian landmass. Fossil evidence found by the Gilroys in Australia suggests that *Homo erectus* may have evolved independently in Australia from an Australopithecine offshoot about the same time.

In June 1997 I uncovered a limestone mineralised incomplete skull from deposits dating around 800,000 to 1 million years BP outside Mudgee in the NSW Central West.

Much of the cranium is missing and the vault filled with sediment now turned to limestone. The mandibular processes are missing, particularly on the right facial section which is also gone. The left brow ridge is distorted downwards, but what remains of the facial section shows that it projected forwards. The skull is long and narrow, that is 'doliocephalic'. It is in fact an 'Archaic' *Homo erectus*.

Conservative paleoanthropologists maintain that the first anatomically modern humans, *Homo sapiens*, evolved in Africa by 150,000 years BP supporting the liberal and globalist claim that we are related to Africans! This is nonsense for reasons too detailed to go into here. However, fossil evidence from Australia unearthed by the Gilroys shows that 'archaic' *Homo sapiens* had evolved from *Homo erectus* by around 500,000-400,000 years BP.

That is the age of an ironstone mineralised cranium recovered by me from Pleistocene deposits in North Katoomba in November, 1974. The cranium is brachiocephalic, that is rounded as in modern skull-types, although there is a backward-sloping forehead.

And to finally bury the "Out of Africa" and "Aborigines the First Australians" 'politically correct' dogma, just west of the Blue Mountains at the Fish River near Tarana two fossil skull-

Pre-history In The America's: Also Changing Australia's Place

In the first of a number of articles, Kevin McCauley will examine the pre-history and ancient history of the Pacific Rim.

THE discovery of Kennewick Man in 1996 in the North West of the United States, brought attention to the argument, now becoming treated as fact, that white Caucasians and other non-Amerindian races, lived in North America in remote pre-history.

Indeed, this theory was advanced in the 19th Century and was subsequently suppressed by an academic establishment so as to eradicate all evidence or knowledge of Caucasians, both modern and archaic in North America prior to the Viking Age.

But some truth will out. More likely, as a *current* Smithsonian Institute anthropologist Douglas Owsley announced in October 2012 in Washington State, Kennewick Man came from the coast, not the arid inland valley where his remains were found. In his book *Their Skeletons Speak: Kennewick Man and the Paleoamerican World*, he documented new DNA and physical findings. It was also said that Kennewick man was also like the New Zealand Morioris' ancestors, the Ainu, who lived in coastal areas of mainland Asia 15,000 years ago. These groups also contained proto-Caucasoid blood.

Previously, the Smithsonian Institute had long suppressed evidence of pre-historic white settlements. The Smithsonian executive, John Wesley Powell, had been living among the Native-Americans and sympathized with their plight. He did lay down the law that the Institute would adopt an isolationist approach that the North American Indians were the "first" Americans and had no connection with others. Any evidence that said otherwise was ignored.

On the other hand Ernest Servier Cox, a well known 19th Century racial anthropologist, as was his compatriot Madison Grant, believed to the contrary. Both had a great respect for the American Indians and Grant was a conservationist who urged that they be protected.

Cox and Grant concluded that the Amerindians, particularly the Plains Indians were an archaic fusion of Mongoloid (Eskimo) with archaic Caucasoid like Cro Magnon Man.

The present day American Indian industry has done all that it can to prevent ancient skeletons that are clearly not Amerindian in the contemporary sense, from being DNA tested. In Australia and New Zealand, we encounter similar situations with Aboriginal and Maori industries that have a similar motivation in suppressing knowledge of the presence of early Caucasoids in Oceania.

The American Indian industry claims all pre-Columbian skeletons as Indian and therefore belonging to them exclusively as they see fit. However, Indian legends state that other races lived in North America as well as later Native-Americans. Legends describe a race of white-skinned red haired race of giants.

that was exterminated by them.

This race was called 'Si Te Cah'. The Indians state clearly: "my people say that the tribe we exterminated had reddish hair." No discussion of possible lost races or civilisations on the North American Continent is possible without a look at the last Ice age and its effects.

Ice Ages start and end in such a manner that it is highly disturbing in that a ten year period all of the ice that had gripped North America had melted and sea levels world wide rose dramatically over a very short period of time. Ice Ages can also start in the blink of an eye.

In the Lightknov Islands off Siberia, the broken bodies of millions of animals including bison, woolly mammoths and other ancient species, were found frozen and in their stomachs, undigested were flora and fauna used as food not normally grown in Arctic conditions, but nonetheless frozen along with the host animal that consumed it. Clearly, they were snap-frozen.

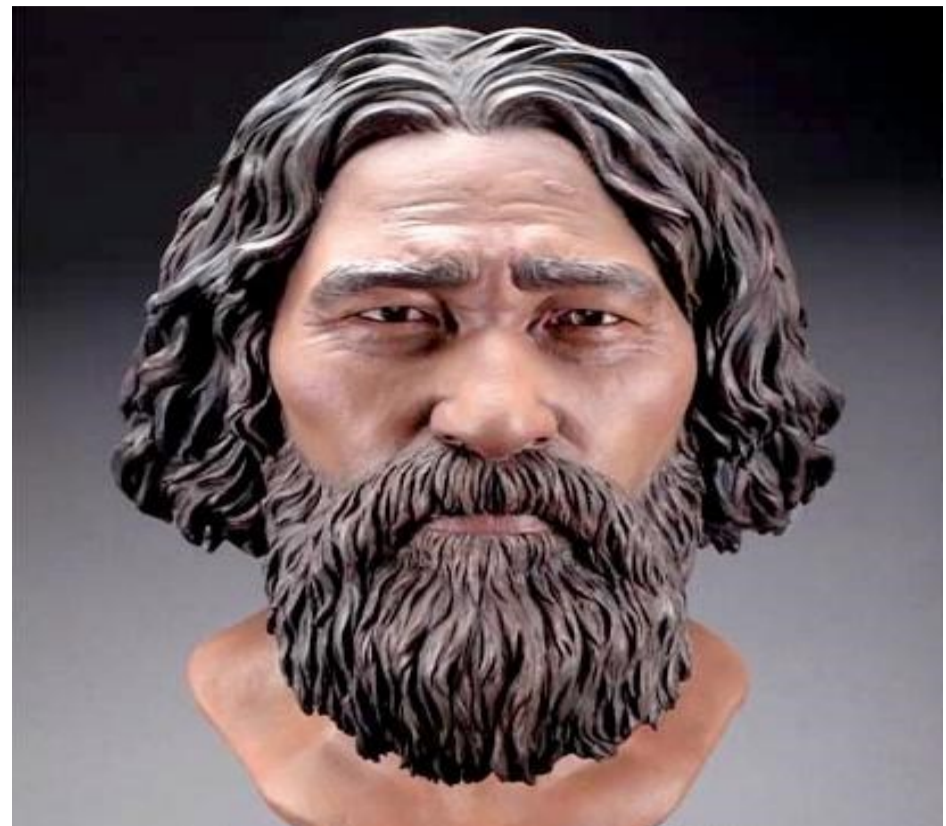
Could a civilisation also have existed that was equally and suddenly destroyed by this Ice Age? Whilst most evidence of a civilisation would have been obliterated by millions of tonnes of moving ice, there still remains evidence of such a civilisation. In 1940, an ancient settlement was discovered in North Alaska at Point Hope, known as Ipiutak; this settlement had well over 800 structures laid out carefully and well planned, with defined avenues. This settlement appears to have supported a culture of 7000 individuals. It seems that these people had a knowledge of mathematics and astronomy comparable to the ancient Maya. Archaeologists are amazed that a settlement of this size could have existed this far north on the Arctic Ocean.

Could this settlement pre-date the last Ice Age? The Ipiutak cemetery reveals that the inhabitants were tall, slender, blonde haired people similar to the Cro Magnons of Europe. The Cro Magnons very rapidly branched out with one group assuming a very ruddy pigmentation which would account for the people exterminated by the Indians. In truth, as Cox and Grant brought out, they were not entirely exterminated but partly absorbed into the Amer-Indian population, making it a prehistoric fusion of ancient Caucasoid, archaic Eskimoid and possibly other races.

Russian archaeologists discovered the remains of several prehistoric settlements similar to Ipiutak in North-Eastern Siberia. Ancient ruins have also been discovered at Spitzbergen to the north of Norway on the Arctic Circle. Ancient Greek and Celtic myths describe a civilisation far to the north - Hyperborea. It was known to the Teutons as Ultima Thule. The recent works of Russian Professor Alexander Dugin deal with this civilisation and are available on the Internet:

In Yakotia, palaeolithic rock drawings have been discovered that are very much like cave paintings of

Magdalenian France and Spain. The only possible link between Cro Magnon Europe is through the north and via a lost white civilisation along the Arctic Circle. Indeed perhaps, the last people from this civilisation existed into historic times when they apparently vanished or assimilated into modern European stocks.

In Alaska, this ancient white race is known as the Alaskan Mummy People. There was a still a remnant of these people in Alaska when the Russians arrived in 1741 (Alaska was part of the Russian Empire till sold to the United States in 1867 as a territory). This race used a decimal system that could tabulate up to 100,000 and a twelve month calendar. They had a knowledge of astronomy and anatomy and could even perform operations such as the removal of eye-abscesses. This race was one of brave warriors who drove the Russians back at Kodiak Island, with heavy losses of ships and men.

This remarkable ancient people had been fighting a long war against the far more numerous Eskimos who slowly pushed them back over a period of several thousand years. The modern Aleut are a mixture of this race and Eskimo and many scientists believe this vanished race could be related to the ancient Ainu of northern Japan and particularly those in Hokkaido where they remain still in a strongly undiluted form. This archaic Caucasoid race (Ainu) originally occupied all of the Japanese islands and far into Polynesian from Neolithic times until they were exterminated / assimilated by the invading Mongoloid Japanese who, like their Korean cousins, are related to the Chinese. All of these sub-races are modern, modified, off-shoots of Peking Man. Peking Man was according to Carleton S. Coon, the erectus progenitor of the 'Mongoloid' race and its subsequent sub-races just as modern Europeans have Neanderthal or archaic Caucasoid Homo Erectus origins. We may reject the 'out of Africa thesis' as usually expressed and prefer Coon's concept of *polycentric origins* for mankind. This would accord with common sense.

The last word on lost civilisations I leave to noted historian, Will Durant

In his *Story Of Civilisation*, he said: "Immense volumes have been written to expound our knowledge and conceal our ignorance, of primitive man ... Primitive cultures were not necessarily the ancestors of our own, for all we know they have been the degenerate remnants of higher Cultures that decayed when human leadership moved in the wake of the ice.

types were found in the 1970s, which to me clearly show that modern humans evolved in Australia before they did in Africa.

In May 1972 my late father Mr W F [Bill] Gilroy recovered a limestone mineralised skull endocast of an 'archaic' Homo sapien from Pleistocene deposits dating around 300,000 to 350,000 years BP. The gravels from which the fossil was extracted were part of a former Pleistocene [Ice-Age] course of the Fish River.

Then in April 1973 on a return visit to this site with my father, from the same stratified deposits as the first skull, but 33.3 metres distant, I recovered a smaller limestone mineralised endocast which, despite it being incomplete with much of its rear cranial area missing, displays thick brow ridges, a forward-projecting facial area and a receding forehead. Reconstruction also revealed the complete fossil would have been doliocephalic. The skull is that of a 'late' form of Homo erectus.

The evidence shows that surviving populations of 'late' Homo erectus were sharing the countryside with groups of their offshoot, Homo sapiens as late as 300,000 years ago. The first wave of Aborigines would not appear on the shores of northern Australia for perhaps at least another 250,000 years!

Caucasians In The Pre-Historic Pacific

Dr. Kerry Bolton

THERE has been a decades' long offensive against European peoples in all parts of the Earth led by the USA at the behest of global capitalism. The ideal is to create a new class of technocratic nomads who can be transplanted anywhere in the world as corporate strategies dictate. This ideal has been expressed in books such as *The Global Me* by G Pascal Zachary, who even lauds this global Homo Economicus as the next stage in human evolution (1). The economic ruling class has no attachment to a land or a culture and aims to recreate humanity in its own image.

The offensive against European peoples and nations most often takes the form of postcolonial and postmodernist propaganda – fancy terms for Marxism– in damning Europeans for having 'stolen the land' from the non-European races, and having dispossessed the 'indigenous peoples'. Paradoxically, the call for indigenous rights for Afrikaners, Felings, or Britons can never be heard from the same quarters who are vehement advocates of the American Indian, Maori or Australian Aborigine, and multitudes of others. Quite the contrary, anyone who dares speak of the rights of Britons or Afrikaners is pilloried as a 'racist', or a 'nazi'.

Another major aspect of this anti-European offensive has been to consign to the Memory Hole as 'outdated' and 'disproved', scholarship that traces the migrations of Caucasoid peoples over the surface of the world centuries before the 'Age of Discovery'.

Even until the 1960s individuals such as Thor Heyerdahl (2) of the famous Kon Tiki (3) and Ra expeditions, and the New Zealand-born, Harvard professor Barry Fell (4), could get an intelligent hearing in mainstream media for the theory that Caucasian peoples traversed the seas, reaching the Americas, and into the Pacific thousands of years ago. While the discovery of ancient proto-Celtic mummies (Tocharians) in the Tarim Basin, China (5), should have given pause to the ridicule that proto-Celts and other ancient Caucasoid peoples could have reached the 'New World' centuries ago, the deniers of European heritage have merely become more vociferous in their condemnation of heretical researchers.

Urukehu: Red Haired Peoples

The irony is that these mostly Marxist critics in their ridicule and smear-mongering also spit upon the legends of the Polynesians, Aborigines, Indians and Maori themselves. Among all these peoples called 'indigenous' are legends of the first people being described as white skinned, blue eyed, and red or blond haired. Throughout Polynesia they are called 'kehu' or 'red heads' and in New Zealand 'urukehu'. The scholar Edward Treager wrote of the urukehu throughout Polynesia:

"I have not yet found kehu in Maori standing alone, but it may be traced in its compounds—viz., makekehu, light-haired, and urukehu, light-haired. The Polynesian shows this to be a strong secondary

meaning. Samoan, 'efu, reddish-brown: Tahitian, ehu, red or sandy-coloured, of the hair, roureuhu, reddish or sandy hair: Hawaiian, ehu, red or sandy hair, ruddy, florid; ehuahiahi, the red of the evening, or old age; ehukakahiaka, the red of the morning, or youth: Tongan, kefu, yellowish, applied to the hair: Marquesan, kehu, fair, blonde; hokehu, red hair; oioikehukehu, daybreak: Mangarevan, keukekura, blonde, fair: Paumotan, kehu, blonde, fair-haired." (6)

Some of the colonial illustrations of the Maori depict urukehu individuals. James Cowan, in *The Maori: Yesterday and Today* shows a picture of a girl with the caption: 'Urukehu girl, of the Urewera tribe at Mataatua (Ruatahuna). This is the ancient fair-haired type, pure Maori'. (7) The early New Zealand painter G F Angus reproduced in his book *The New Zealanders* a painting entitled: 'Children of the boiling springs by Taupo Lake'. The painting depicts three Maori children, the centre boy having blond hair (8). A photograph of an urukehu boy was published in *The Old-Time Maori* by the famous Maori guide Mākereti Pakura, and is identified as 'uruehu' by her (9).

Legends of Turehu

The Maori referred to the Caucasoid tribes as Patupaiarehe and Turehu. There are specific names and genealogies for some of these tribes, and the descendants of them even continue to exist as peripheral remnants labelled as 'Maori', despite their objections.

There are numerous theories as to the origins of these Caucasian remnants. The Ngati Hotu ascribes their origins to Egypt and Iran. Waitaha, which claims to be an amalgamation of ancient Polynesian, Caucasoid and Asian (or Eurasian) races asserts multiple origins in the Americas, Tibet and Egypt.

Nonetheless, even the Ngati Hotu and Waitaha claim to have arrived here after the Turehu. Researchers have advanced multiple origins for the Turehu. Martin Doutré considers them to be proto-Celts (10) especially on the basis of standing stone alignments in New Zealand, which are similar to those of the Old World. Dr Barry Fell, a Harvard zoologist, who gained later fame as a multi-linguist and an epigrapher deciphering ancient rock inscriptions, traces Caucasoid migrations back to an Egypto-Libyan expedition across the Pacific ca. 200BC, pointing to many Libyan scripts found across the Pacific, including New Zealand and reaching America. Thor Hey-

erdahl, whose Kon Tiki balsa raft sailed from South America into Polynesia, and his Ra reed boat from the Middle East to America, believed that much of Polynesia was settled by a first wave of Caucasoid migrants from South America. Earlier scholars traced Aryan migrations from India. It is only in recent decades that academe has become dominated by a theory that claims a single origin for all Polynesians from the hill tribes of Taiwan, and it is claimed that world genetic mapping has settled the matter once and for all.

Recently it has been found that the controversial Kennewick Man skull found on the banks of Washington's Columbia River in 1996, and often contended to be Caucasian, is related to both Chatham Islands Moriori and the Ainu, who are archaic Caucasoids. Yet, an interesting sidelight is that we have been told for several decades that the old scholarship was wrong about Moriori being a separate race, and that they were simply Maori who fled to the Chatham Islands. It is believed that Kennewick Man was part of a widespread migration from Asia across the Pacific (11). As we know for sure from the proto-Celts of the Tarim Basin, 'Asian' does not necessarily mean Mongoloid.

Early Observations

Many European explorers and the earliest settlers recorded their surprise at seeing Caucasoid types among Polynesians and Maori. The first Europeans of the 'Age of Discovery' to come to a Polynesian island were the Spaniards of the Mendana Expedition in 1595, which reached the Marquesas. Quiros stated of the 400 natives who paddled towards the ship that many were 'almost white, many of them were ruddy'. (12)

Easter Island was first reached by the Dutch under Roggeveen from South America in 1722. Behrens records the complexions of the islanders were 'brownish, others darkish, others quite white', while some had a reddish, sunburnt tint. One native who came aboard ship was 'an entirely white man'. (13) The explorer Beachey reached Tuomatua in 1825 and commented on the 'light skin and European features' of the islanders. (14) Capt. Cook said of the Tahitian women that they were 'almost as fair as Europeans'. The Marquesan women and youths were 'as fair as

in his second voyage Cook records that in Tonga among the natives there were 'hundreds of truly European faces'. In Hawaii the natives looked like Europeans. (16)

Of course, the postmodernist (i.e. Marxist) 'scholars' who discount such eyewitness testimony state that the European colonialists were simply projecting their own biases onto what they thought they saw. This however does not account for the descriptions of distinctly different racial types among the natives, and the meticulous accuracy of the European scientists on board ship in recording what they observed. Hence postmodernist historian Professor Kerry Howe of Massey University, New Zealand, states in his supposedly 'devastating critique' of heretical theories on Polynesian settlement: 'We not only construct our own past, but the history and cultures of others. This Howe calls 'intellectual colonisation'. (17)

Ngati Hotu

A remnant of the Ngati Hotu remains, and is aggrieved at the manner by which their very existence has been ignored, and like the Waitaha, subsumed by Maori assertiveness and state acquiescence to Maori demands. The Ngati Hotu occupied much of the central North Island, but were pushed inland by the Maori tribes over centuries, until their last battle in Whanganui during the 14th century resulted in their massacre and dispersal of the survivors. Yet a remnant continues to live at Whanganui, one of their spokeswomen stating in a submission to the Waitangi Tribunal: 'Nevertheless, the blood still thrives in our veins; it hasn't been extinguished and absorbed. Some might be embarrassed by the fact that their ancestors lost a few battles, but it's who we are. We have no choice, it is our identity'. (18) The Ngati Hotu submission states that they 'descend from the Urukehu, a people renowned for their fair skin, green eyes and red hair'. (19)

Monica Matamua recalls that as a child going to school among the Maori she was bullied and her hair pulled because it was red and she was urukehu and Ngati Hotu.

The ancient history of New Zealand's Caucasian heritage is slowly gaining

"Somewhere in the mystic future, on the road to Paradise,
There's a very pleasant country that I've dreamed of once or twice..."
(Otherside, 1891)

This is Lawson "the Prophet".

"I was born to write of the things that are!
And the strength was given to me;
I was born to strike at the things that mar
The world as the world should be!"
(The Writer's Dream, 1897)

What would life be like in this land of ours, if the People of Australian ethnicity were to force the governments of Australia to adopt Lawson's philosophy of Australianism as the *Policy of the State*, instead of *Multiculturalism* - as is the case today? (1)

"'Twas a land set apart for a nation...
And the people be wise and prosper,...
And the wealth of the people only
Be told by the wealth of the State..."
('Twas A Land Set Apart, 1899)

Lawson would have had the entire Australian People enjoying the wealth that Australia produces. And

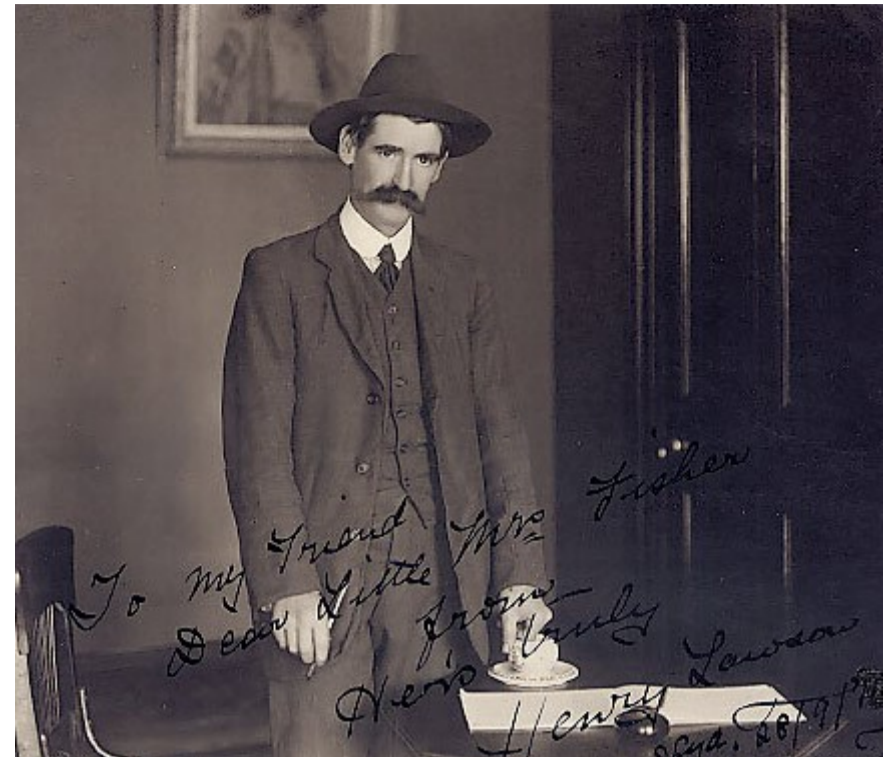
"Prove ourselves worthy the land we inherit now,

And with the death of *foreignism* and the rebirth of Australian self determination and faith in ourselves alone,

In his country's hour of need;
Many inventors whose young hearts burn
to show what the South can do!
Practical teachers we have at hand,

On Arthur Calwell And Henry Lawson

Editor, A.F. Norwick

Henry Lawson and Arthur Calwell believed in an ideology known as "Socialism without doctrines", the original *nationalist* economic programme of the old Labour movement and party, which involved class collaboration in a productive national community. Today, this ideology is known as *producerism*.

Calwell said in *Be Just And Fear Not*:

"I still think that Australia needs the sort of revolution that will produce fundamental far-reaching changes. Every country needs such a revolution every now and then to make some beneficial changes in its social, political and economic affairs. England needed a violent revolution to get rid of Charles I and then peaceful revolution after the Restoration to get rid of his ill-fated son, James II in 1688.

The last thing I want to do is shock native born reactionaries and kill them off prematurely by hinting at the word revolution in this country. Yet what else is there to talk about if man is to survive in the mess that capitalism has made of our society with its wars, its pollution of the air, the sea and the land and its degradation of our moral, social and economic health?

The Eight Core Policies Of Australia First: A Programme And A Method For National Rebirth!

2 THE Eight Core Policies of Australia First are the basis of association for the party. They are (with explanations and the implied ninth point) as follows:

1 Ensure Australia Retains Full Independence

Protect our sovereignty (national, constitutional and personal) and maintain an adequate defence, whilst being reasonable and fair in our nation's international dealings.

2 Rebuild Australian Manufacturing Industries

This is the only way we can be self-sufficient. It will provide jobs for our children, and help buy back the farm and allow Australia to be free of foreign debts. Our infrastructure has been run down over many years - it must be rebuilt. We must improve the practicality and relevance of our educational systems, and target government support for industry to diversify, innovate, perform and expand. We recognise that small business is fundamental to this policy. A satisfactory financial environment is also urgent and essential.

3 Control Foreign Ownership

Bring foreign ownership and investment back under control.

4 Reduce and Limit Immigration

Immigration mistakes can be big long-term mistakes. Immigration policy must take into account social cohesion, employment opportunities, urbanisation and environmental issues

5 Abolish Multiculturalism

End the divisive, government-funded and institutionalised policy of multiculturalism.

6 Introduce Citizen-Initiated Referenda

Amend the Australian Constitution such that the people can initiate a constitutional referendum which, if approved by the Australian people, will amend the Australian Constitution. This simple step will confirm the political authority of voters and make legislators aware that they are the servants of the Australian People, not their masters. The people directly should also possess the sovereign right and the power to initiate other legislation

7. Strengthen the family

Promote policies that strengthen and protect the traditional family.

8 Strive to Rebuild A United Australia

Promote policies that recognise the interdependence of city and country.

9 Democratise Other Policy Issues

All other policies (non-core policies) are matters of free conscience and are not binding upon Australia First's future parliamentarians or councillors who are to represent their electorates.

Issues of public interest on which Australia First needs to formulate policy will be canvassed with the party membership, and plebiscites conducted where deemed appropriate by the party's National Council. The party also permits branches to formulate specific electoral policies or community policies not inconsistent with the Eight Core Policies.

From time to time, the party will issue material that provides interpretation of the core policies. This interpretative material would reflect the spirit of the party.

The organizational purpose for this statement of policy and system for policy creation is simple: Australia First does not require weighty tomes which change from month to month, as do the programmes of the Establishment parties and those who ape them. It requires a focus for action and for unity within the party.

Australia First is to build a new national movement. Practicality is method.
