We are instructed to act on behalf of the CFMEU (Construction & General Division) NSW Branch (referred to herein as the NSW Branch) and its officials Mr Brian Parker, Ms Rita Mallia and Mr Darren Greenfield whose names and images appear in an article on your website.

We enclose for ease of reference an eight (8) page printed screen shot copy of the above said article taken today.

We are instructed none of the above named officials from the NSW Branch authorised use of their images on your website. We demand the said images be removed from your website forthwith.

In relation to the substantive article you have published on your website we draw your attention to the Interim Report tabled in federal Parliament on 19 December 2014 by Royal Commission into Trade Union Governance and Corruption. In relation to allegations concerning dealings between Mr Parker, Mr Greenfield and Mr George Alex it is clear no findings have been made to date by the Commissioner and further issues of fact on this are pending before the Commission and in the case of Mr Greenfield in proceedings before the Supreme Court.

Further your website article contains a number of grossly inaccurate statements that carry defamatory imputations about the NSW Branch and certain officials. In the writer's legal opinion these statements go beyond the scope of "fair reporting" or "opinion" and do not entitle you as publisher of them to claim a defence under the law of defamation. Our client requests that you withdraw the above said website article from your website forthwith.
