# FIREARMS PROGRAMME

#### PREAMBLE

This Firearms Programme prescribes Administrative Procedure to re-empower Native Australians with inherited civil rights, including National Defence obligations, rebutting the political caste and the globalist UN Agenda for disarmament of citizens. It intends for reinstatement of established law Magna Carta, Bill Of Bights and (

reinstatement of established law [Magna Carta, Bill Of Rights and Common Law].

The construction of the Administration Procedure to be legislated through the Federal Parliament as an Act under the Defence Power as per the Constitution of Australia, and including for the nullifying of the undemocratic National Firearms Agreement. #### PROGRAMME


- 1. A *People's Commission For Firearm Regulations* to be enacted under Law in the Federal Parliament of The Commonwealth of Australia.
- 2. Delegates to be appointed by consensus to the Commission, to create effective Firearm Regulations, and draft Firearm Law for legislation.
- 3. Delegates to be appointed to the People's Commission from:
  - I. Firearm Owners and Shooters Organisations
  - ii. Ratepayer or similar Public Citizen Bodies
  - iii. Farming and Agricultural Producer Organisations
  - iv. Returned Services League
  - v. Australian Conservation and Wildlife Groups
  - vi. Public Feral Pest Control Departments

vii. Public Conservation and Environment epartments

viii. National Park Authorities

- ix. Australian Defence Force
- x. Australian Firearm Manufacturers
- xi. Firearm Retailers Association
- xii. Federal Minister Department of Defence
- 4. The People's Commission to oversee Firearm Regulations, and to receive monies paid by Firearm Owners and Organisations, to advance aims commensurate with responsibilities with firearm permits, and High Culture Values. Delegate expenses to be met under allowances drawn therefrom.
- 5. The Commission to advance National Manufacturing for required firearms and consumerables connected thereto used in Australia.
- 6. The Commission to contribute to Public Service Authorities directions for the eradication of crimes by gun armed/drug connected criminals.

- 7. The Commission to access Judicial Empowerment to undertake public enquiries into matters of firearm incidents, past and present, for the public good.
- 8. The Commission to be within the Jurisdiction of the Federal Minister for The Department of Defence.

### **OBJECTIVES**

- 1. Native Australians to be re-empowered to control and approve Firearm Regulations, and Permit standards, for enactment under Federal Law.
- 2. Firearm Ownership to be restored to a responsible and acceptable component of Australian Society.
- 3. The use of firearms for personal and home defence against invasion to be returned to legality at common law.
- 4. Firearm Organisations and Owners to contribute and participate in conservation, ecological retentions and land management activities.
- 5. The restitution of State Police, from politicised and corporatised "law enforcers", to Crown Law Officers protecting Citizens.
- 6. Firearm Permits to include for suitable membership of a reinstated Citizens Volunteer Force as at Federation, extending into community based activities.
- 7. Firearm Organisations to participate in Australian Youth Development Programmes.
- 8. The reduction of excessive violence portrayed in entertainment media.
- 9. The dismantling of the disarmament agenda activated by the Lib/Lab/Greens political caste under UN Globalising objectives.
- 10. To deconstruct the negativity perception actively dumped upon Firearm Owners by the Lib/Lab/Greens political caste.
